

## **Terms & Conditions**

### **PAW Patrol Little Heroes Paw Awards Competition (the “Competition”)**

The Competition is governed by these terms and conditions (the “Terms”) and by entering the Competition, entrants agree that they have read and understood these Terms and will be bound by them.

#### **IMPORTANT INFORMATION**

- #### **WHO CAN ENTER?**

- 4. To enter the Competition:**  
To enter the Competition you need to do the following between the

#### **Opening Date and the Closing Date:**

#### **GENERAL**

**16. Entries received after the Closing Date will not be valid. Spin Master is not responsible if your Entry gets lost, delayed, misdirected, undelivered, damaged or if you have technical problems trying to enter the Competition.**

**17. Please take care when entering the Competition to ensure that you provide your correct contact details. Any Entries which are incomplete and/or can't be read clearly will not be valid and won't be entered into the Competition.**

**18. Spin Master shall at its sole discretion determine whether an Entry is valid, based on the entry requirements set out in these Terms. Each valid entry will be entered into the Competition.**
